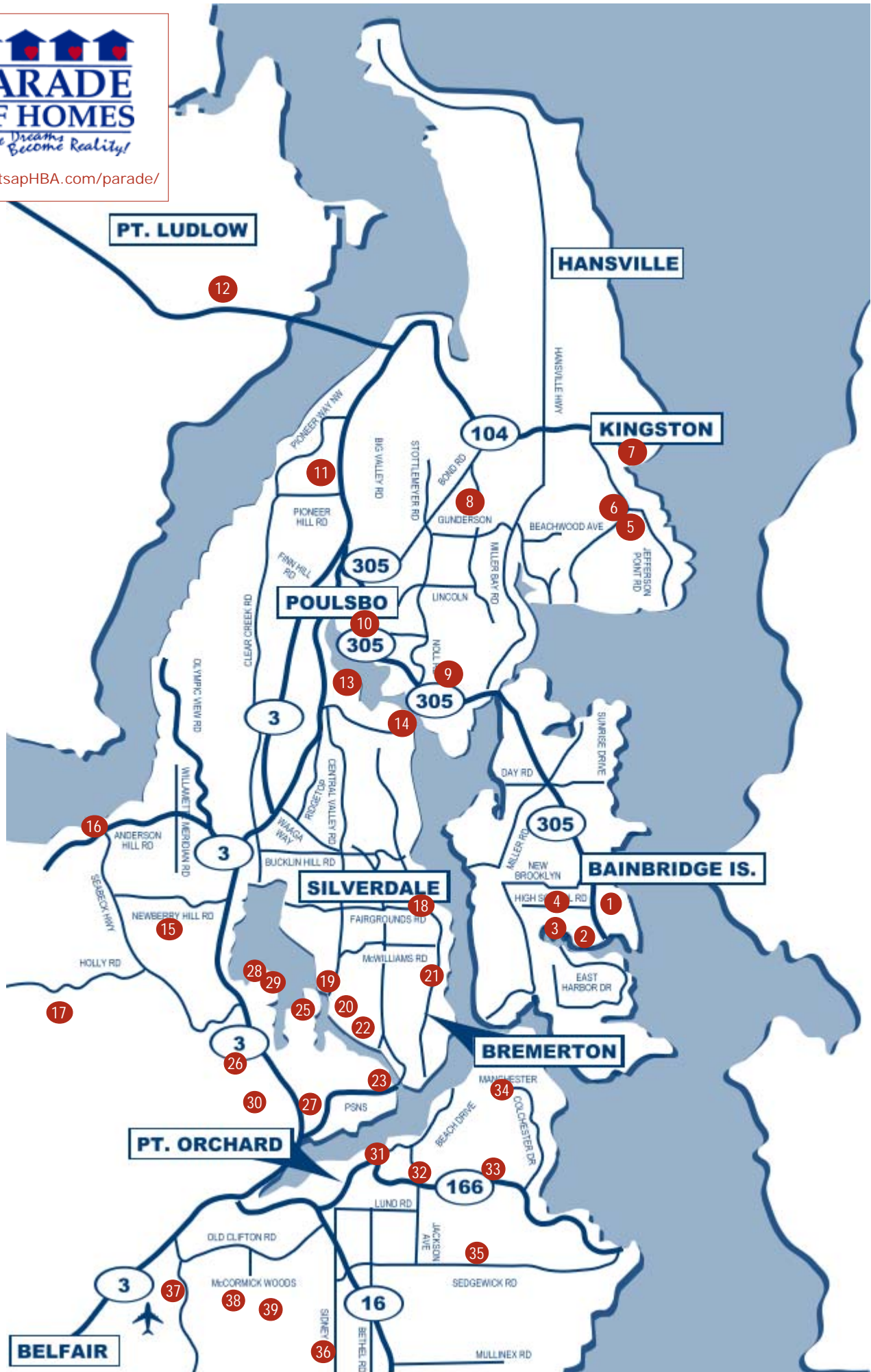

## 1 - Pacific Heights Construction

682 State Hwy 305 - J301

Hwy. 305 to Bainbridge Island. House located 1/2 mile S. of the Hwy. 305/High School Rd. intersection.

## 2 - Fairbank Construction Company

144 Hall Brothers Loop NW #33

From Hwy. 305 or Bainbridge Ferry Dock to Winslow Way W. Continue W. past Madison Ave. Madrone Village on right.

## 3 - Landmark, LLC

785 LedgeStone Loop

From Winslow, take Wyatt Way W. toward Eagle Harbor. At the Y, follow Wyatt up the right. Right onto Bucklin Hill Rd. Go 1/4 mile to Ridge Lane and turn right. Follow Ridge Lane past Haley Loop to LedgeStone Loop to address.

## 4 - Base Capital, LLC

300 NE High School Road, #203

Hwy. 305 or Bainbridge Island Ferry Dock to NE High School Rd., continue W. Site on right.

## 5 - Coyote Hollow Woodworks, Inc.

22921 Singingwood Place

S. Kingston Rd. to White Horse Dr. Left on Singingwood.

## 6 - Akamai Homes, LLC

9800 NE White Horse Drive

Hwy. 104 to Kingston. Right on Lindvog at light. Right on W. Kingston Rd. Left at 3-way stop on S. Kingston Rd. 3 miles to entrance to White Horse Golf Community and White Horse Drive. Home on right.

## 7 - Central Sound Construction, Inc.

26726 Sunnyview Lane

Hwy. 104 to downtown Kingston. N. on Ohio. Right on Sunnyview Lane. Continue straight to sign on left.

## 8 - Ritzman Construction, LLC

4727 NE Rova Road

N. on Bond Rd. E. on Gunderson Rd. Left on Rova Rd. Home on left.

## 9 - Chaffey Homes

2753 NE Noll Valley Loop

Hwy. 305, E. on Lincoln Rd. S. on Noll Rd.

## 10 - Central Highland Builders

125 Sunset Street

From Hwy. 3 (N. or S.) take the Poulsbo/Bainbridge exit and head E. to Bond Rd. Turn right and travel to intersection at Front Street. Turn left and follow along towards Poulsbo. Turn left onto Sunset St. Home is on the right. From Bainbridge, cross the Agate Pass bridge and travel towards Poulsbo. Turn left at Hostmark St. Travel into downtown Poulsbo (Hostmark turns into Front St.) Go through town up to Sunset St. and turn right. Home is on the right.

## 11 - Grandview Development, Inc.

29233 Brownlee Place NE

N. Hwy. 3. Left on Falkner Rd. 1/4 mile to Brownlee Place NE. Left on Brownlee Place NE. 1st drive on left.

## 12 - West Harbor Homes

570 Mount Constance Way

Hwy. 3 N. to Hood Canal Bridge. Left over Hood Canal Bridge/WA 104 N. Immediately after bridge, right on Paradise Bay Rd. Travel for approx. 5 miles. Turn left on Teal Lake Rd. Follow Teal Lake for 3/4 mile. Right on Springwood Dr. Left on Mt. Constance Way and arrive at the Olympic Terrace Development.

## 13 - Bushnell Homes, Inc.

16161 Pearson Point Road

N. on Hwy. 3 to Keyport exit. Go E. then L at traffic signal at Scandia Rd. Right onto Virginia Loop. Straight ahead to Pearson Pt. on left. Follow to 16161 Pearson Pt. on left.

## 14 - Ferguson & Cole, Inc.

1788 Poulsbo Ave.

E. on 308 to Keyport. Left on Poulsbo Ave. Home is on right.

## 15 - DBC Construction, LLC

8511 Knute Lane NW

From Hwy. 3 take Newberry Hill Rd., E. on Silverdale Way. Left on Knute Lane NW. Go to end of street. Property on left.

## 16 - Sterling Custom Homes

5898 Larson Lane

E. or W. on Seabeck Holly Hwy. to Larson Lane (S.) of Seabeck Marina. E. on Larson Lane past entry to Seabeck Heights. Home is approximately 1 mile up the rd. on the left after Deer Haven before Cheyney.

## 17 - Five Star Development, LLC

601 Riverview Road

Seabeck Hwy. to W on Seabeck Holly Rd. W. on Tahuyeh Lake Rd. Right on Kingsway. Straight on Riverview.

## 18 - Jafa Enterprises, Inc.

7618 Hoogenraad Place

Hwy. 303 to E. John Carlson R. Top of hill turn left onto Hoogenraad Place, follow signs.

## 19 - D Lane Homes

6048 Pahrman Place NW

From Silverdale Bucklin Hill Rd. turn right on Tracyton. Turn left on Schuyler Rd. (just past Stampede Blvd.) Immediate left onto Pahrman Place NW. Last house on left. From Bremerton Riddle Rd: Turn right on Tracyton. Turn right on Schuyler, (just past left tight curve). Immediate left onto Pahrman Place NW.

## 20 - Camp Corporation

101 E. 29th Street

Sylvan Rd. left on Ricky. Right on 29th to "Vintage Hills." Or, from Tracyton Beach Rd., follow signs.

## 21 - Jafa Enterprises, Inc.

2213 Riddell

Turn E. onto Riddell from Hwy. 303 (Wheaton Way). Go past Almira and Petersville Rd. 2nd drive on right. Look for sign.

## 22 - Camp Corporation

3835 Earendale Avenue

Riddell Rd. to left on Pine Rd. "Brandywine" on your left.

## 23 - Kitsap Co. Housing Authority

360 Washington Ave, # D107

E. on 6th St. Right on Pacific. Left on 2nd. Cross Washington Ave. Turn left into parking lot.

## 24 - Kitsap Co Housing Authority

**CANCELLED**

Immediate left into parking lot. Follow signs on Washington to Open House. Short distance from lot to building.

## 25 - Pristine Homes

2961 Rocky Point Road

From Hwy. 3, take Kitsap Way E. Turn left on Marine Dr. (N.) Right on Rocky Point Rd. Look for signs on left.

## 26 - Bushnell Homes, Inc.

1602 W. Kitsap Lake Road

W. on Kitsap Way, bear left onto Northlake Way. Left on Kitsap Lake Rd. Go 0.1 mile to 1602 Kitsap Lake Rd. on the left.

## 27 - Habitat for Humanity of Kitsap Co.

New Hope Circle

From Hwy. 3: exit at Loxie Eagans Blvd. From north: turn left onto Loxie Eagans Blvd. Continue straight past the intersection with National Ave. Turn right at stop sign on Arsenal Way. New Hope site is two blocks ahead on the left just past Marion.

## 28 - Cedar Bay Homes, Inc.

4492 Dyes Inlet Road NW

From Hwy. 3 take Chico Way exit. Turn S. on Chico Way NW. Turn left (E.) on NW Erland Point Road. Turn left on Kittyhawk Dr. NW. Turn right on Dyes Inlet Rd. NW. Follow directional signs to home.

## 29 - Cedar Bay Homes, Inc.

4504 Dyes Inlet Road NW

From Hwy. 3 take Chico Way exit. S. on Chico Way NW. Left (E.) on NW Erland Point Rd. Left on Kittyhawk Dr. NW. Right on Dyes Inlet Rd. NW. Follow directional signs to home.

## 30 - Cascade Specialties

1216 Humphrey Avenue

From Hwy. 3 exit on Auto Center Drive (Loxie Eagans) and go left. Left on Oyster Bay Ave. Right on Roosevelt Blvd., to right on Humphrey Ave. to home on right at end.

## 31 - Pristine Homes

259 Caseco Lane

Take Hwy. 16 towards Port Orchard. Take Tremont exit (E.) to downtown. Left on Port Orchard Blvd. Follow to end at Bay St. Follow to Caseco Lane. Left on Caseco and follow up winding hill to house at end overlooking bay.

## 32 - American Dream Homes

1890 Redwood Drive

From Mile Hill drive, turn left onto Retsil Road. Go to just past Kitsap Bus Transit on left across from soccer fields.

## 33 - Pacific Kai Homes, LLC

6241 E. Krystal Woods Way

E. on Mile Hill. Left (N.) on Woods Rd. Left on E. Krystal Woods Way to 2nd home on right.

## 34 - Custom Structures, Inc.

8042 E. Aguilar Court

E. on Mile Hill Dr. to Colchester Dr. Left onto Puget Dr. Right on Aguilar Ct. Go to end, home on right.

## 35 - Deltora Construction

7145 Sedgwick Road

Hwy. 16, E. on Sedgwick Rd. Follow signs to house.

## 36 - Newell Homes, LLC

9601 Dickenson Road

From Hwy. 16, head SW on Sedgwick Rd. for 5 miles to the home on the left. (Note: Sedgwick Rd. becomes SW Lake Flora Rd., SW Lake Flora becomes Dickenson Rd.)

## 37 - Yee Construction Corp.

7767 Cynthia Lane, SW

Hwy. 16, exit on Old Clifton Rd. Left on Sunnyslope 1.4 miles to right on Cynthia Lane to home.

## 38 - Pacific Bay Homes, LLC

6130 Gleneagle Avenue SW

West on Old Clifton Rd., to McCormick Woods. Turn into McCormick Woods. Left onto MaryMac Ave. Right onto Gleneagle Ave. House on right.

## 39 - Pioneer Builders, Inc.

7325 Hawkstone Avenue SW

W. on Old Clifton Rd. to McCormick Woods. Turn into McCormick Woods. Left onto Mary Mac Ave. Left onto Hawkstone Ave. House on right.
